



## **Extended Care Program Fees & Application**

### **Before School Care**

Supervised care is available for students arriving at school between 6:45 and 7:45. Students arriving for Earlycare are admitted at Entry 2 and supervised by a staff member until released to classrooms @ 7:45 am. Breakfast is available to students @ 7:35 am in the café for \$2.05 per meal. The adult breakfast price is \$2.25. Students will not be admitted to the building before 6:45 am. In the event of a 2 hour delay, there is no Earlycare.

### **After School Care**

Supervised care is offered daily beginning at 11:00 am for preschool students and after dismissal for elementary and middle school students. Aftercare ends at 5:30 pm. Supervision, nutritious snacks, and recreation are provided each day.

Morning preschool students staying after the 11:00 am dismissal time go to the cafeteria for lunch at \$2.80/day. Milk (\$.60) or juice (\$.75) may be purchased to accompany a packed lunch. Students are taken to the Extended Care room after lunch and recess.

Students in grades K-8 staying for Aftercare will report to the extended care room at dismissal. Students are separated by age groups in order to provide better activities and a safer environment for each child.

### **EXTENDED CARE FEES**

#### **Before School Care**

\$2.50 daily per student

#### **Morning Preschool Aftercare**

Dismissal – 3:00 pm \$8.00

3:00 – 5:00 pm \$2.50 per hour per child

5:00 – 5:30 pm \$1.25 per child

After 5:30 pm late fee \$5.00 per child

#### **Elementary/Middle School Aftercare**

3:00 – 5:00 pm \$2.50 per hour

5:00 – 5:30 pm \$1.25 per hour

After 5:30 pm late fee \$5.00 per child

**Fees are the sole support of the Extended Care Program. All Extended Care bills are sent home in Monday folders and payment is due on Wednesday of that week. Any balance over \$100 will result in suspension of services until balance is paid.**
