

Extended Care Program Fees & Application

Before School Care

Supervised care is available for students arriving at school between 7:30 and 7:45am. Students arriving for Earlycare are admitted at Entry 3 and supervised by a cafeteria staff member until released to classrooms @ 7:45am. Breakfast is available to students @ 7:35am in the café for \$2.60 per meal. The adult breakfast price is \$3.10. No students are admitted to the building prior to 7:30am. Breakfast is not served after 7:50am.

After School Care

Supervised care is offered daily beginning at 2:30pm for preschool students and after dismissal for elementary and middle school students. Aftercare ends at 5:30pm. Supervision, snacks, and recreation are provided each day.

Students in grades PK-8 staying for Aftercare will report to the Café at dismissal to sign in. Students must be signed out by a parent or guardian. In any other case, arrangements must be made prior to pick-up.

Fees are the sole support of the Extended Care Program. All Extended Care bills are available electronically in PowerSchool and updated on Monday of each week. Payment is due on Wednesday of that week. Any balance over \$50 will result in suspension of services until balance is paid.
